

RoHS Compliance — June 2015 Update (EU RoHS 2 Directive (2011/65/EU))

This summary provides the status of compliance with the RoHS Directive and associated activities for HydraForce.

What are the RoHS Directives?

RoHS stands for the Restriction of Hazardous Substances. There are three specific European Union Directives that restrict the use of materials on specific products placed on its internal market listed below.

Restricted hazardous substances		
< 0.1% lead	< 0.1% mercury	polybrominated biphenyls (PBB) < 0.1%
< 0.01% cadmium	< 0.1% hexavalent chromium	polybrominated diphenyl ethers (PBDES) < 0.1%

HydraForce's Commitment

“HydraForce products meet RoHS environmental requirements restricting the use of cadmium, quick silver, lead hexavalent chrome, polybrominated biphenyl (PPB) or polybrominated diphenyl Ester (PPDE) in valve and manifold products and packing materials.

All HydraForce valve and manifold products meet requirements limiting the use of hazardous materials as identified in OSHA Standard 1910.1200(g), Directive No. 2002/95/EC, Directive No.2000/53/EC, Directive, 65/2011/EU and EU RoHS 2 Directive (2011/65/EU) .
